Building Out the Next Classroom

As we were preparing for our 33rd annual Salute to Catholic School Alumni dinner event last March, I called on a donor to see if he would serve as a Benefactor of the event.

Each year, our Benefactors are the lifeline of this event, each donating \$25,000 or more to the fundraising success of the evening. Ten years ago, we had seven Benefactors and raised \$550,000 at the event. Last year, we were accompanied by 34 Benefactors and garnered an all-time record \$1.4 million for the benefit of our young Catholic school students. In a word, "WOW!!"

After I made my pitch to him, he asked me a very good question. "If I donate \$25,000 to the event - a lot of money for me - how much good will that do?"

Thankfully, I knew the answer.

Last fall, along with our funding partners (the Archdiocese of Louisville, the schools themselves and Community Catholic Center), we awarded scholarships to an all-time high 3,600 Catholic elementary students with record funding of an astounding \$7.7 million. Of that amount, about \$4 million, or \$1,100 per student, came out of the Foundation's coffers.

So my answer was this. "If you invest \$25,000 in this event, you will be solely responsible for providing a Catholic education to 22 young students next fall. **A full classroom of kids!!**"

To which he simply responded, "Count me in."

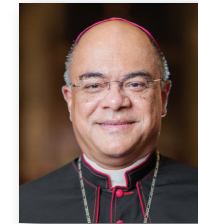

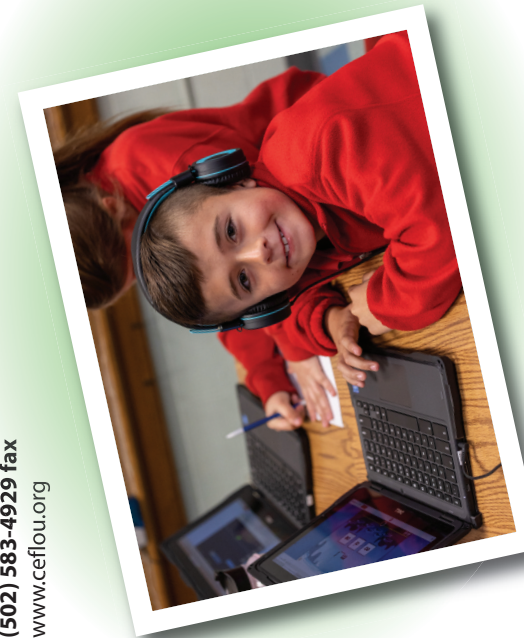
