One-Half of New Fund to Benefit Saint James School in Louisville's Highlands Neighborhood

On September 20, the Foundation and Saint James Catholic School jointly announced that **Sarah and John Lechleiter** plan to donate \$10 million to establish a new tuition assistance endowment fund for Catholic elementary school families across central Kentucky, one-half of which will be dedicated to helping families in need at Saint James School in central Louisville.

Foundation President **Rich Lechleiter** remarked, "The single largest endowment addition in our history, this truly amazing gift represents a huge leap forward in our plans to provide a Catholic elementary education to more

For the 2023/2024 school year, the Foundation and its funding partners recently awarded tuition assistance to an <u>all-time high 3,700</u> elementary students with an <u>astounding record \$8 million</u> in funding, rocketing past last year's previous records of 3,600 and \$7.7 million, respectively.

Valentina's Story

Now in my 10th year at the Foundation, I'm not sure we've ever seen a time when the news is this overwhelmingly good! A record 3,700 students earning tuition assistance awards this fall. A sold-out Salute to *THE GAME* luncheon event that netted an astounding record \$600,000 for our mission. And an off-the-charts endowment gift of \$10 million to bolster the futures of thousands of families in need for generations to come.

Wow!! It's hard to think that things could get any better!

But they will. How do we know that? Because of a young student whom we introduced at the *Salute* luncheon event named **Valentina Rocha**.

Several years ago, as a young girl, she and her parents immigrated to the United States from South America, where they joined Valentina's uncle here in Louisville. From there, the family started from scratch, with little resources and lots of needs.

Her mother cleaned houses, her father was a mechanic, and the two of them worked nights with their start-up cleaning business – all to gain a used car and a small apartment.

For Valentina, a Catholic elementary education was not even on the radar – until she discovered the Catholic Education Foundation at St. Rita Parish in Okolona. With scholarship in hand, she began her Catholic school journey in the fifth grade, assimilating into a new culture, growing academically, and forming in her Catholic faith.

That small start at St. Rita School later landed her at Mercy Academy, where she graduated in 2022 through the financial assistance program there including a special fund for Hispanic students in need.

Today, she is a sophomore at the Speed School of Engineering at the University of Louisville, thriving as never before. She has great ambitions, wanting to land a career in the automotive industry and perhaps starting her own business in the future.

Of even greater importance, she wants to help her parents and, over time, provide the gift of a Catholic education to someone else. Just like the one she received.

You see, for Valentina and thousands of our students like her, things have only just begun to get better. For each of them, the best is yet to come.



Let's all give thanks to the Lord that a record number of families can have access to this life-changing opportunity called Catholic education."

Dr. Mary Beth Bowling, Superintendent of Catholic Schools, commented, "The collaboration between the Catholic Education Foundation, the Archdiocese of Louisville and our Catholic schools is propelling so many families to heights they never imagined for their children. What could be better!"

The record \$8 million of funding was provided by the Foundation (\$4.3 million), parishes and schools (\$2.3 million), and the 110 parishes of the Archdiocese of Louisville, along with Community Catholic Center, (\$1.4 million).

and more deserving students each year. When fully funded, the new fund will provide \$400,000 to \$500,000 annually in new tuition assistance funding – forever! How God-blessed is this organization by Sarah and John's generosity!

Saint James School holds a special place in the Lechleiter family history, with John's late father, John Howard Lechleiter, a proud member of the Class of 1942. Founded in 1906 in Louisville's Highlands neighborhood, the school has produced an array of community leaders in business, government, the professions, education, religion, and not-for-profit organizations throughout its rich history.

Today, the school's students come from many parts of the community, including Louisville's West End and Portland neighborhoods. Saint James is the Foundation's fourth highest-funded school, with approximately 90% of the students receiving aggregate tuition assistance of over \$350,000 annually. John noted, "It's important to Sarah and me that the unique mission of Saint James School continues. The new \$5 million fund dedicated to the school and its students in need will help ensure that families can send their children to the school with joy and confidence in its future!"

The other half of the new \$10 million fund will provide tuition assistance to students in need across the Archdiocese of Louisville. The administration of the new fund, including the investment management and annual allocation of student awards, will be managed by the Foundation.

Archbishop Shelton Fabre exclaimed, "This is a major breakthrough in the Foundation's strategic plan to expand its impact and perpetuate its mission! How blessed are we to have such generous benefactors as Sarah and John – both Louisville Catholic school graduates who share their blessings with others."

Foundation Board Chair Todd Klimek remarked, "Gifts like Sarah's and John's give great hope to thousands of families in need who only dream of a Catholic education for their children. As we look forward, this gift will turn that dream into their reality. Indeed - like never before - at the Catholic Education Foundation of Louisville, "The Answer is YES!"

Both raised in Louisville, Sarah and John attended Catholic elementary schools and went on to graduate from Sacred Heart Academy and Saint Xavier High School, respectively. Their family has resided in Indianapolis since 1979, where John spent a 37-year career with Eli Lilly and Company, retiring as its Chief Executive Officer in 2016 and its Board Chair in 2017. Today, they enjoy spending time with their three children and nine grandchildren. ■







The Foundation recently added five new members to its Board. Here's a brief introduction of each of them:



Reverend Shayne R. Duvall - Father Shayne attended St. Lawrence School and then graduated from Holy Cross High School, after which he earned his undergraduate degree in Justice Administration from the University of Louisville in 2005.

In 2007, Father Shayne began his seminary studies and graduated from St. Meinrad Seminary and School of Theology in 2015. While at St. Meinrad, he obtained his Masters in Theological Studies and Masters of Divinity degrees. He was ordained to the priesthood by Archbishop Joseph E. Kurtz on May 30, 2015.

He has served as an Associate Pastor at St. James Parish in Elizabethtown, St. Ambrose Parish in Cecelia and St. Ignatius in While Mills. In 2017, he was assigned as Administrator of St. Raphael the Archangel Parish and was installed as its Pastor the following year. In 2022, Father Shayne was assigned to Holy Trinity Parish in St. Matthews, where he currently serves as its Pastor.



Mary B. Ewing – Born and raised in Bardstown and the eldest of two children, Mary graduated from Bethlehem High School and went on to launch a successful career in sales, marketing and interior design.

In 1989, she joined Vencor, Inc. as Office Manager and later became Assistant to the Founder, Chair and Chief Executive Officer of the company, W. Bruce Lunsford, until his retirement in 1999. Mary now serves as Executive Vice President of Lunsford Capital, LLC, a private investment firm, and as Secretary and Treasurer of the W. Bruce Lunsford Foundation, Inc.

Mary has a long record of service to her community and her church, having served as a Board member of the Louisville Ballet, the Kentucky Derby Festival and Showcase Greater Louisville, among others. Mary and her husband, Jim, have two adult children, Anne and James, and are members of Holy Trinity Parish.



James A. "Ja" Hillebrand – The seventh of eight children, Ja attended Holy Spirit School and later graduated from Saint Xavier High School in 1987. He then attended Bellarmine University, earning his undergraduate degree in business administration.

Then it was on to a career in banking, eventually joining Stock Yards Bank and Trust Co. in 1996 where he developed the Private Banking Group. He later led the bank's expansion into Indianapolis and Cincinnati. In 2008, Ja was appointed President of the company and joined its Board of Directors. In 2018, he was named Chief Executive Officer and assumed the additional role of Board Chair in 2021.

Ja's community service is extensive, with Board roles in Boy Scouts of America, Greater Louisville Foundation, Kentucky Derby Museum, Fund for the Arts, Kentucky Derby Festival and St. Joseph Children's Home, among others. Ja has three adult children and two grandchildren.





James J. Kirchdorfer, Jr. – Jimmy attended St. Leonard School and graduated from Saint Xavier High School, where he was a member of the State Championship Golf Team in his senior year. He later earned his undergraduate degree in business from Miami University in 1991.

He then joined the family business, ISCO Industries, leading the company to become a global leader in the piping products industry with more than 35 locations and 600 employees worldwide. Today, Jimmy serves as the Chair and Chief Executive Officer of the company.

He is an avid golfer and an advocate for the game's positive impact on young people, serving on the Boards of The First Tee of Louisville, Golf Course Builders of America Foundation, and

the Kentucky Golf Foundation. Along with three local partners, Jimmy is the co-owner of Louisville's famed Valhalla Golf Club.

Jimmy and his wife, Dana, have two adult children, Jay and Emma, and are members of Holy Trinity parish.
