

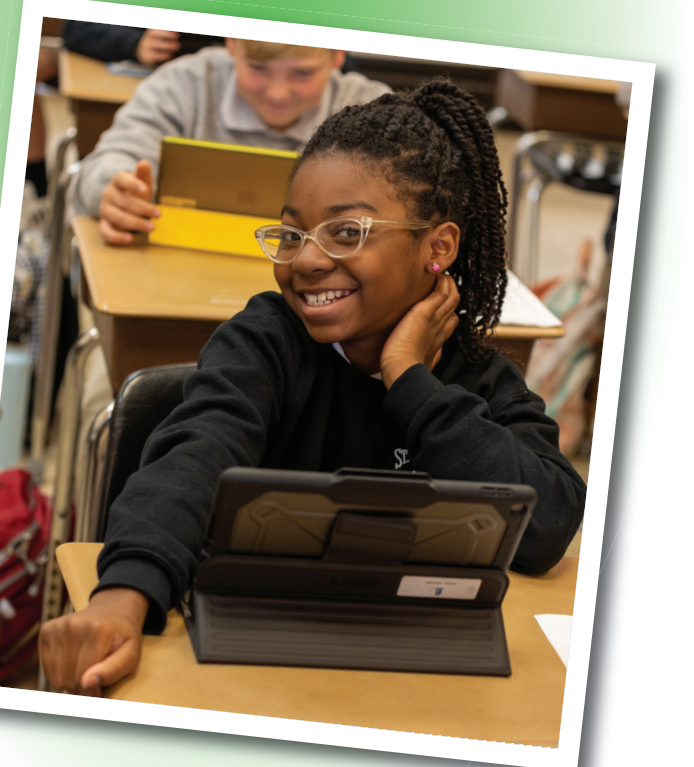

For the past 34 years, the Catholic Education Foundation has hosted the annual Salute to Catholic School Alumni dinner, recognizing Catholic school alumni who have made a significant impact in their communities. This hallmark fundraising event generated an all-time record **\$1.6 million** in Catholic school tuition assistance funds in 2024. In celebration of the nationally recognized rivalry and thrill of the annual Saint Xavier - Trinity high school football game, the Catholic Education Foundation hosts the annual Salute to **THE GAME** luncheon. In only its sixteenth year, this unique fundraising event netted a record **\$600,000** in 2023. The 2024 Salute to **THE GAME** luncheon is set for noon on Thursday, September 26 in the Grand Ballroom at the Galt House Hotel in downtown Louisville.

The Foundation's fourth annual **Bourbon Raffle** will launch on February 4 and end on March 24, 2025. This exciting online event will feature 25 prize lots with over 100 unique and rare bourbons. Indeed, like never before, for all our Catholic school families in need, **"The Answer is Yes!"**

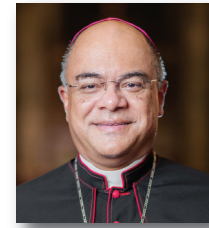
